The Broken Record Award



We call this the "broken record" award because it reminds us of a person who doesn't take "NO" for an answer. They may keep repeating the same message over and over again because it's something they believe in.

This award is given to a Self-Advocate who is good at speaking up for themselves and others. If you know a person with a disability who is very determined, sticks to their beliefs and follows their dreams, please nominate them for this award. After all, speaking up about the things that are important in life is what Self-Advocacy is all about!

The Leadership Award



This award is given to a Self-Advocate, or Self-Advocacy group, that has demonstrated genuine leadership qualities. While many Self-Advocates are great at speaking up for themselves, leaders are those people who also help others to find and use their own voice. The things that a genuine leader does, and the way that they live their lives, make a positive difference for others who have a developmental disability.

We give this award to remember past leaders of the Rhode Island Self-Advocacy Movement who are no longer with us, and to honor the leaders of today. If you know one of those leaders, we hope you'll nominate them for this award!

The Friend of Self-Advocacy Award



There are some people here in Rhode Island who do a lot to support Self-Advocacy, but they never "blow their own horn". These friends volunteer their time and go above and beyond to help individuals and local Self-Advocacy groups grow.
